Funded Early Education Entitlement
- for eligible children the term after 9 months old.***

Universal Funded Early Education Entitlement
- all children the term after their 3rd birthday.

We offer **FEEE only hours** in various patterns which, include the following:

All funded hours are stretched over 50 weeks (with Bank Holidays and Christmas - New Year deducted).

Choose your own package scale of fees explained

Your child's nursery place is secured when availability has been confirmed, and on completion of a registration form, plus **£50.00** deposit per session of attendance. The deposit will be deducted from your first month's fees.

FEEE only hours are calculated by the following method:

$$\begin{aligned} 15 \text{ hours} \times 38 \text{ weeks} &= 570 \text{ hours} \\ \div 50 \text{ weeks} &= 11.4 \text{ hours per week} \\ &\text{over 2 sessions = no charge} \end{aligned}$$

Optional enhancements, for example:

Consumables and activities contribution -
£3.12 per hour x 5.75 hours x 2 sessions = £35.88

Food -
Breakfast £3.00 + snack £1.00 + lunch £6.50 = £10.50
x 2 sessions = £21.00

Weekly total = £56.88

Payment can be made via bacs using your child's surname as a reference or childcare vouchers or Tax-Free Childcare to:

Funded Early Education Entitlement is applied, for eligible families, the term after your child is 9 months old, or the term after their 3rd birthday for all children.

As a full daycare provision, we stretch the 38 weeks of funded hours across 50 weeks.

Optional enhancements are charged on attendance and invoiced monthly.

Parents can find out about the government's Tax-Free Childcare at: www.beststartinlife.gov.uk - if eligible, this will save you 20% of your childcare costs, up to £2,000 per child per annum. Tax-Free Childcare can be used in addition to receiving the FEEE.
