Your child's nursery place is secured when availability has been confirmed, and on completion of a registration form with a £50.00 registration fee, **plus** £100.00 deposit per day of attendance. The deposit will be deducted from your first month's fees.

### Monthly fees are calculated by the following method:

Weekly fee multiplied by 50 weeks, divided by 12 = 12 monthly payments of the same amount every month, despite the number of weeks in each month.

### For example

0 - 3 years, attending 3 days per week:

Daily rate **£98.70** x 3 days      = **£ 296.10** per week  
x 50 weeks  
÷ 12 months = **£ 1233.75** per month

---

Funded Early Education Entitlement is applied, for eligible families, the term after your child is 9 months old, or the term after their 3rd birthday for all children.

As a full daycare provision, we stretch the 38 weeks of funded hours across the 50 weeks invoiced in equal monthly payments, please see our funding policy and funding parental agreement.
